Principles for allocating seats on committees and delegations:

- 1) In as far possible, the order of preferences is respected, but all choices (1st, 2nd and 3rd) are valid.
- 2) Returning Members are given preference when requesting seats on committees/delegations previously occupied
- 3) Allocation of seats will take due account of ensuring geographical and gender balance
- 4) Preference will be given to delegation leaders, when committee seats are contested between two otherwise equally entitled Members
- 5) No more than one full Member of the same national party on the same committee/delegation, except where the national party exceeds 10 Members, or where there are free seats
